## **SUMMARY**

This proposed law would prohibit Massachusetts from imposing any tax, fee, revenue-generating measure, or market-based compliance measure if it would

FILING DEADLINES. Initiative petitions must be submitted to local election officials for certification of signatures no later than 5 p.m. on Wednesday, November 17, 2021. Local election officials must complete their certification no later than November 29, 2021. Thereafter, initiative petitions containing certified signatures must be retrieved by petitioners from the local election officials and then filed with the Elections Division, Office of the Secretary of the Commonwealth, One Ashburton Place, Room 1705, Boston, MA, no later than 5 p.m. on Wednesday, December 1, 2021.
